Times & Traditions may display items in a variety of forums, such as antique malls, flea markets and/or shows. Selection of appropriate forum(s) will be at the discretion of Times & Traditions.

Although every care will be taken, items are left at consignor's risk. Times & Traditions assumes no responsibility for loss or damage during transportation, packaging, storage, display, customer handling, theft, fire, flood, or act of God.

Items will be kept for sale for 4 months, unless specifically noted on the attached list(s). At the end of the agreed upon period,

**\*\* Should the consignor choose the "return" option, Consignor will receive 40% of the selling price.**

The items listed below will be returned to the consignor. To reclaim unsold items at the end of the contract period, the consignor must call 410-744-9000 prior to the end of the agreement period. Times & Traditions will gather those unsold items and contact the consignor when they are ready to be picked up. It may take several weeks to gather the unsold items. Times & Traditions will hold items for two weeks after contacting the consignor. After which, Times & Traditions will donate them to charity. Please note the consignor will receive 40% of the selling price.

If the consignor should decide to terminate this contract before the four months have elapsed, Times & Traditions will charge a 25% restocking fee for the items researched and put on the market.

Checks that amount to \$30 or more will be mailed to the consignor on or about the twentieth of the month following the month of the sale.
